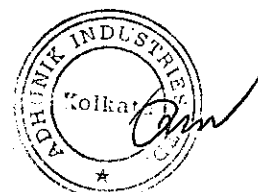
Please find below the outcome of the meeting of Board of Directors of the Company held today the 12th August, 2016:
